Background

Since the end of the Cold War, the world has enjoyed almost three decades of peace and economic prosperity. Northeast Asia has been at the epicenter of such transformation, serving as a key locomotive for global economic growth and ushering in an era characterized by the "Rise of Asia." Since the mid-2010s, however, Northeast Asia and the Pacific have been faced with unprecedented challenges at unseen speed and scope.

These challenges center around the escalating hegemonic rivalry between the U.S. and China, which first started off as trade war but has rapidly spilled over into the realm of technological innovation. One area of the rising concern and huge implications for the region is the increasing competition in global supply chains, especially with regard to advanced technologies, including 5G, semiconductors, bioscience, rare earth elements, EV battery, etc. Establishment of their norms and standards are becoming increasingly important in preventing any major potential bifurcation in global supply chains.

Against this backdrop, the Chey Institute for Advanced Studies, supported by the SK Group, proposes a bipartisan dialogue inviting the world's most influential opinion leaders, scholars, and incumbent/former high-ranking officials from the United States, Korea, and Japan. This "Trans-Pacific Dialogue" aims to address the most pressing global challenges or crises we face today, including, but not limited to, the following: U.S.-China rivalry; Indo-Pacific strategy; denuclearization of North Korea; and the impact of scientific innovation and new technologies, focusing on global supply chains.

USA



Richard ARMITAGE is former Deputy Secretary of State, serving from 2001 to 2005. From 1989 through 1992, he filled key diplomatic positions as presidential special negotiator for the Philippines Military Bases Agreement, special mediator for water in the Middle East, and a special emissary to Jordan's King Hussein during the 1991 Gulf War. He also served as Assistant

Secretary of Defense for international security affairs from and Deputy Assistant Secretary of Defense for East Asia and Pacific affairs.



Robert D. ATKINSON is the Founder and President of the Information Technology and Innovation Foundation, recognized as the world's top think tank for science and technology policy. Previously, Dr. Atkinson was Vice President of the Progressive Policy Institute and Director of PPI's Technology & New Economy Project. He received his Master's in Urban and Regional

Planning from the University of Oregon, and received his Ph.D. in City and Regional Planning from the University of North Carolina at Chapel Hill.



Kurt CAMPBELL is Deputy Assistant to the President and Coordinator for Indo-Pacific Affairs on the National Security Council, and Chairman and CEO of The Asia Group. During the Obama Administration, he served as Assistant Secretary of State for East Asian and Pacific Affairs. He was awarded the Secretary of State's Distinguished Service Award for his advance-

ment of a comprehensive U.S. strategy in Asia in 2013. He received his Ph.D. in International Relations from Oxford.



Victor CHA is a Senior Adviser and the inaugural holder of the Korea Chair at the Center for Strategic and International Studies. He is also the D.S. Song-KF Professor of Government at Georgetown University. Dr. Cha was the Deputy Head of Delegation for the U.S. at the Six-Party Talks in Beijing and received two Outstanding Service Commendations during his

tenure. Dr. Cha holds a B.A., an M.I.A., and a Ph.D. from Columbia University, and an M.A. from Oxford University.



Tarun CHHABRA serves as a Special Assistant to the President and Senior Director for Technology and National Security on the National Security Council staff. From 2015-2017 he served as NSC Director for Strategic Planning and Director for Human Rights and National Security issues. He was a Senior Fellow at the Center for Security and Emerging Technology at

Georgetown University. Dr. Chhabra earned a J.D. from Harvard, an M. Phil. in International Relations from Oxford, and a B.A. from Stanford.



Cynthia COOK is Director of the Defense-Industrial Initiatives Group and a Senior Fellow in the International Security Program at the Center for Strategic and International Studies. Her research interests include defense acquisition policy and organization, the defense industrial base, new technology development, and weapon systems production and sustainment. Dr.

Cook holds a Ph.D. in Sociology from Harvard University and a B.S. in Management from the Wharton School of the University of Pennsylvania.



Wendy CUTLER is Vice President at the Asia Society Policy Institute (ASPI) and Managing Director. In these roles, she focuses on building ASPI's presence in the nation's capital and on leading initiatives that address challenges related to trade, investment and innovation, and women's empowerment. She joined ASPI following a career of nearly three decades as a dip-

lomat and negotiator in the Office of the U.S. Trade Representative, where she also served as Acting Deputy U.S. Trade Representative.



Robert EINHORN is a Senior Fellow with the Arms Control Initiative and the Center for 21st Century Security and Intelligence at the Brookings Institution. Previously, Mr. Einhorn served as the State Department Special Advisor for Nonproliferation and Arms Control. In that capacity, he played a leading role in the formulation and execution of U.S. policy toward

Iran's nuclear program. He holds a B.A. in Government from Cornell University and a M.A. in Public Affairs and International Relations from Princeton University.



Evan FEIGENBAUM is Vice President for Studies at the Carnegie Endowment for International Peace, where he oversees research encompassing both East Asia and South Asia. He was the 2019-20 James R. Schlesinger Distinguished Professor at the Miller Center of Public Affairs at the University of Virginia, where he is now a Practitioner Senior Fellow. Initially an aca-

demic with a Ph.D. in Chinese Politics from Stanford University, Feigenbaum's career has spanned government service, think tanks, and the private sector.



Edwin FEULNER is Founder and former President of The Heritage Foundation. After serving as president from 1977 to 2013, Dr. Feulner served as president again for a brief period in 2017. Dr. Feulner graduated from Regis University with double majors in English and business, and received an M.B.A. from the University of Pennsylvania's Wharton School of Business.

He later attended Georgetown University and the London School of Economics, and then earned a doctorate degree at the University of Edinburgh.



Michael GREEN is Senior Vice President for Asia and Japan Chair at the Center for Strategic and International Studies (CSIS). Dr. Green has served on the staff of the National Security Council (2001-2005), first as director for Asian affairs with responsibility for Japan, Korea, Australia, and New Zealand, and then as special assistant to the president for national security affairs and

senior director for Asia, with responsibility for East Asia and South Asia.



Chuck HAGEL served as the 24th Secretary of Defense for the United States from 2013 to 2015. Secretary Hagel's current commitments include service on the Board of Trustees of RAND, Centennial Scholar at the Georgetown Walsh School of Foreign Service, and Distinguished Statesman at the Atlantic Council. Secretary Hagel also served two terms in the United States

Senate as the representative from Nebraska, during which he was a senior member of the Senate Foreign Relations, Banking, and Intelligence Committees.



Bill HAGERTY represents the state of Tennessee in the United States Senate, and previously served as the U.S. Ambassador to Japan from 2017 to 2019. Senator Hagerty worked as an economic advisor and White House fellow during the George H.W. Bush administration. Senator Hagerty received his B.A. in Economics and Business Administration from Vanderbilt University, and

earned his J.D. from Vanderbilt Law School, where he was a Patrick Wilson Scholar.



John IKENBERRY is the Albert G. Milbank Professor of Politics and International Affairs at Princeton University in the Department of Politics. Among his many activities, Professor Ikenberry served as a member of the Policy Planning Staff in 1991-92, as a member of an advisory group at the State Department in 2003-04, and as a member of the Council on Foreign Relations Task

Force on U.S.-European relations, the so-called Kissinger-Summers commission.



Seth JONES is Senior Vice President, Harold Brown Chair, director of the International Security Program, and director of the Transnational Threats Project at the Center for Strategic and International Studies (CSIS). Prior to joining CSIS, Dr. Jones was the Director of the International Security and Defense Policy Center at the RAND Corporation. He specializes in irregular

warfare, counterterrorism, and covert action. Dr. Jones is a graduate of Bowdoin College and received his M.A. and Ph.D. from the University of Chicago.



Atul KESHAP currently serves as the U.S. Chargé d'Affaires in India. As a career Foreign Service Officer, Ambassador Keshap has served in many roles throughout government, including as Deputy Assistant Secretary of State for South Asia and the United States Senior Official for Asia Pacific Economic Cooperation, and the U.S. Ambassador to Sri Lanka and Maldives. He is also the recipient of

several Department of State Superior and Meritorious Honor Awards. Ambassador Keshap received his Bachelor's and Master's degrees from the University of Virginia.



Tsu-Jae King LIU is the Dean of the College of Engineering at the University of California, Berkeley. Her honors include the Ross M. Tucker AIME Electronics Materials Award, the Intel Outstanding Researcher in Nanotechnology Award, the IEEE Aldert van der Ziel Award, and the Defense Advanced Research Projects Agency Significant Technical Achievement Award for

her role in developments in FinFET. Dr. Liu earned her B.S., M.S. and Ph.D. degrees in Electrical Engineering at Stanford University.



Bruce KLINGNER specializes in Korean and Japanese affairs as a Senior Research Fellow at The Heritage Foundation. Mr. Klingner served for 20 years in the Central Intelligence Agency and the Defense Intelligence Agency, including as the CIA's Deputy Division Chief for Korea. Mr. Klingner is a distinguished graduate of the National War College, where he received a mas-

ter's degree in National Security Strategy. He also holds a M.S. degree in Strategic Intelligence from the Defense Intelligence College.



Marc KNAPPER has served as Deputy Assistant Secretary for Korea and Japan since August 2018. Prior to assuming this position, Marc served in Seoul as Chargé d'Affaires and as Deputy Chief of Mission. He has twice worked in North Korea: in 1997 as the State Department representative to the Yongbyon nuclear facility and in 2000 as a member of the advance team for Secre-

tary Albright's visit to Pyongyang.



John J. MEARSHEIMER is the R. Wendell Harrison Distinguished Service Professor of Political Science at the University of Chicago. In 2020, he won the James Madison Award, which is given once every three years by the American Political Science Association to "an American political scientist who has made a distinguished scholarly contribution to political science." Dr.

Mearsheimer graduated from West Point, and has a Ph.D. in Political Science from Cornell University.



Evan MEDEIROS is a Professor and the Penner Family Chair in Asia Studies in the School of Foreign Service at Georgetown University. He served for six years on the staff of the National Security Council as director for China, Taiwan, and Mongolia and then as Special Assistant to the President and Senior Director for Asia. In the latter role, Dr. Medeiros was President Barack

Obama's top advisor on the Asia-Pacific.



David MOSCHELLA is a nonresident Senior Fellow at the Information Technology and Innovation Foundation, where he assesses the intersection of digital technology and global business competition. He has lectured and consulted on digital trends and strategies in more than 30 countries, working with leading

customers and suppliers alike. He was previously head of worldwide research at The Leading Edge Forum and International Data Corporation (IDC), the largest market analysis firm in the information technology industry.



Joseph S. NYE, Jr. is the University Distinguished Service Professor Emeritus and former Dean of Harvard's Kennedy School of Government. He has served as Assistant Secretary of Defense for International Security Affairs, Chair of the National Intelligence Council, and as Deputy Under-Secretary of State, and won distinguished service awards from all three agencies. Dr.

Nye received his bachelor's degree summa cum laude from Princeton University, won a Rhodes Scholarship to Oxford, and earned a Ph.D. in Political Science from Harvard.



Daniel B. PONEMAN is President and Chief Executive Officer of Centrus Energy Corp. Mr. Poneman has previously held positions as the Deputy Secretary of Energy and as the Acting Secretary of Energy. In prior tours in government, Mr. Poneman served as a White House Fellow and on the National Security Council. Mr. Poneman received A.B. and J.D. degrees with honors

from Harvard University and an M.Litt. in Politics from Oxford University.



J. Stapleton ROY is the Founding Director Emeritus of the Kissinger Institute on China and the United States at the Wilson Center. He joined the US Foreign Service immediately after graduating from Princeton in 1956, retiring 45 years later with the rank of Career Ambassador, the highest in the service. During a career focused on East Asia and the Soviet Union, his am-

bassadorial assignments included Singapore, the People's Republic of China, and Indonesia.



Daniel RUSSEL is Vice President for International Security and Diplomacy at the Asia Society Policy Institute. A career member of the Senior Foreign Service at the U.S. Department of State, he has served as the Assistant Secretary of State for East Asian and Pacific Affairs, as Special Assistant to the President, and as National Security Council (NSC) Senior Director for Asian Affairs. Mr. Russel

is the recipient of numerous awards, including the 2017 Presidential Rank Award.



Rexon RYU is the Managing Partner of The Asia Group and Board Chair of the Asia Group Foundation. Mr. Ryu has served three presidents at the highest levels, including as Chief of Staff to the Secretary of Defense, on the White House National Security Staff, and as Deputy to the U.S. Ambassador to the United Nations. He is also a nonresident Senior Associate at the Carn-

egie Endowment for International Peace.



Gary SAMORE is a Professor of the Practice of Politics and the Director of the Crown Center for Middle East Studies at Brandeis University. Dr. Samore served both President Clinton and President Obama as the senior official in the National Security Council responsible for nonproliferation of weapons of mass destruction. Outside government, he held senior research

and administrative positions at the International Institute for Strategic Studies in London, the Council on Foreign Relations and the Belfer Center.



Susan THORNTON is the former Acting Assistant Secretary for East Asian and Pacific Affairs. She is currently a Senior Fellow and research scholar at the Paul Tsai China Center at Yale University Law School; Director of the Forum on Asia-Pacific Security at the National Committee on American Foreign Policy; and a nonresident Senior Fellow at the Brookings Institution. Thorn-

ton received her Master's in International Relations from Johns Hopkins School of Advanced International Studies and her Bachelor's from Bowdoin College.



Kurt TONG is a Partner and member of the Executive Committee at The Asia Group, and served as Consul General and Chief of Mission in Hong Kong and Macau. Prior to that role, he served as the Deputy Chief of Mission and Chargé d'Affaires at the U.S. Embassy in Tokyo, as Ambassador for Asia-Pacific Economic Cooperation (APEC) and as Director of Korean Affairs

in the State Department's Bureau of East Asia and Pacific Affairs.



M. Stanley WHITTINGHAM is a SUNY Distinguished Professor of Chemistry and Materials Science and Engineering at Binghamton and the 2019 Chemistry Nobel Laureate. He has been active in Li-batteries since 1971 when he won the Young Author Award of the Electrochemical Society for his work on beta-alumina. In 1972, Dr. Whittingham joined Exxon and dis-

covered the role of intercalation in battery reactions. He received his B.A. and D.Phil. degrees in Chemistry from Oxford University.



Joseph YUN most recently served as Special Representative for North Korea Policy. Currently, he is a Senior Advisor with The Asia Group and the U.S. Institute of Peace. Ambassador Yun led the U.S. efforts to align regional powers behind a united policy to denuclearize North Korea from 2016 to 2018. He holds a M. Phil. degree from the London School of Economics and a B.S.

from the University of Wales.

Japan



AKIYAMA Masahiro currently serves as the President of Akiyama Associates and as Chairman at the Society of Security and Diplomatic Policy Studies. His professional career in government includes a number of senior positions, including head of the Banking Investigation Division and Director-General of Tokyo Customs. After moving to the Defense Agency in 1991, he

served as Director-General of the Defense Policy Bureau and the Finance Bureau, and as the administrative Vice-Minister of Defense before resigning from the agency in 1998.



FUJISAKI Ichiro currently holds tenure as the President of the Nakasone Peace Institute and as President of the America-Japan Society of Japan. He served as Ambassador to the United States from 2008 to 2012, and has also served as Ambassador to the United Nations. His other Ministry of Foreign Affairs posts include terms as Deputy Director-General for Asian Affairs, and

Director-General for North American Affairs before being appointed as the Deputy Foreign Minister.



FUJIWARA Kiichi is the Director of the Security Studies Unit at the Institute for Future Initiatives, and a Professor of International Politics at the University of Tokyo. He was awarded the Woodrow Wilson International Center Fellowship in Washington D.C. from 1995 to 1996. Professor Fujiwara is a graduate of the University of Tokyo, a former Fulbright Scholar at Yale Uni-

versity, and has been a faculty member at Chiba University, the University of the Philippines, and Johns Hopkins University.



FUKAGWA Yukiko is currently the Deputy Dean and a Professor in the School of Political Science and Economics at Waseda University. Her major interest lies in economic development in East Asia, especially Korea. She worked for the Japan External Trade Organization and Long-Term Credit Bank Research Institute before teaching at Aoyama Gakuin University and the

University of Tokyo. She received her M.A in International Development Economics from Yale University, and her Ph.D from the Waseda Graduate School of Business Studies.



KITAGAMI Keiro is a Member of the Japanese House of Representatives and is a Guest Professor at the Kyoto University for Advanced Sciences. He served as the Parliamentary Vice Minister of Economy, Trade and Industry from 2011 to 2012, and as Special Advisor to the Prime Minister from October to December 2012. In 2007, Mr. Kitagami was honored as a Young Global

Leader at the World Economic Forum (Davos Forum).



MATSUKAWA Rui is a member of the House of Councillors in Japan and has considerable experience related to foreign policy, especially concerning the relationship between Japan and Korea. Before becoming a diet member, she worked at the Ministry of Foreign Affairs for over 20 years. Until September 2021, she had served as Parliamentary Vice-Minister of Defense and Par-

liamentary Vice-Minister of Cabinet Office, and engaged in work related to various security issues.



MURANO Masashi is a Japan Chair Fellow at the Hudson Institute. His research areas include U.S.-Japan defense cooperation and nuclear/conventional deterrence analysis. Prior to joining Hudson, he was a Research Fellow at the Okazaki Institute, a Tokyo-based think tank. He has more than ten years of experience in tabletop exercises and facilitation of numerous

classified products related to strategic intelligence assessment and policy planning for the Japanese government. Mr. Murano holds an M.A. in Security Studies from Takushoku University.



NAGASHIMA Akihisa is a sixth-term member of the House of Representatives with The Liberal Democratic Party of Japan, where he currently serves as a Ranking Member of the Committee on National Security. He was previously Senior Vice Minister of Defense, and also served as Special Advisor to the Prime Minister. He earned his M.A. in International Rela-

tions/International Economics from Johns Hopkins University, and previously received an LL.M. in Constitutional Law from Keio University Graduate School of Law.



NAKABAYASHI Mieko is a Professor of Political Science at Waseda University. Dr. Nakabayashi in Japan's House of Representatives from 2009 to 2012. During her tenure at the Diet, Nakabayashi served as a Director of the Foreign Affairs Committee; the Financial Affairs Committee; and the Special Committee on Anti-Piracy Measures, Prevention of International
